

**NOTICE OF INTENT TO ACT UPON A REGULATION
NOTICE OF HEARING FOR THE ADOPTION OF REGULATIONS
NEVADA STATE BOARD OF EDUCATION/NEVADA STATE BOARD FOR CAREER AND TECHNICAL EDUCATION**

The Nevada State Board of Education/Nevada State Board for Career and Technical Education will hold a public hearing on **Friday, June 18, 2010**, via video conference at the following locations: Nevada Department of Education Offices, 700 East Fifth Street, Board Room, Carson City; and 9890 South Maryland Parkway, Las Vegas, Nevada.

The time for the public hearing has been scheduled as follows:

**10:15 A.M. Public Hearing and Possible Board Adoption of Proposed New Regulation R031-10;
New Regulations to NAC 385 Regarding Schools in Need of Improvement Relative to
Corrective Actions, Consequences, Supports or Sanctions; Monitoring Implementation of
Corrective Actions; and Turnaround Restructuring Plan Requirements**

NOTE: This is the first and only public hearing and possible action to adopt may be taken.

The purpose of the hearing is to receive comments from all interested persons regarding revisions to regulation language that pertain to **NAC 385** of the Nevada Administrative Code.

The need and purpose of the proposed new regulations are to provide a differentiated system of support and consequences associated with the legislative mandates resulting from the passage of Senate Bill 389 during the 2009 Legislative Session.

There is no economic effect on the Department of Education; and an allocation of established state resources under NRS 385 will cover some costs associated with the regulations, once adopted for the schools and school districts.

There is no cost to the Department of Education to adopt these regulations. There is no federal law affecting the proposed regulations. There is no duplication or overlap of state or local governmental agencies. The proposed regulations do not establish a new fee nor increase an existing fee of the regulating agency.

Persons wishing to comment upon the proposed action of the Nevada State Board of Education/Nevada State Board for Career and Technical Education may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form to the Nevada Department of Education, 700 East Fifth Street, Carson City, Nevada 89701-5096. Written submissions must be received by the Department of Education **on or before Monday, June 10, 2010**. The following statement applies for hearings noticed above for possible Board adoption: If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Education/Nevada State Board for Career and Technical Education may proceed immediately to act upon any written submissions.

A copy of this notice and the proposed regulation will be on file at the Nevada State Library and Archives, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the proposed regulation will be available at the Nevada Department of Education, 700 East Fifth Street, Carson City, Nevada, 89701-5096, and in all counties at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available at the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233b.0653, and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reasons for overruling the consideration urged against its adoption.

This notice of hearing has been filed at the following locations: The offices of the Nevada Department of Education in Carson City and Las Vegas, at the 17 Nevada School District Superintendent's Offices; the 17 county main public libraries, and at the Nevada State Library and Archives.
