- Non-passing of AB 306: Revises provisions relating to the SafeVoice program (BDR-34-19);
- Moving forward, AB 371: Enacts provisions governing discrimination based on race (BDR 34-697);
- Non-passing of SB 76: Revises provisions relating to education (BDR 34-297);
- Non-passing of SB 458: Ensures sufficient funding for public education for the 2021-23 biennium (BDR 34-1169);
- Passing of SB 36: Revises provisions relating to responses to crises and emergencies by schools (BDR 34-296).

Member Dave Jensen brought forward the discussion regarding the jeopardization of sources to funding for social workers, SROs and pupil centered funding. The committee noted several concerns for the change to this funding in relation to the passing of SB 36.
