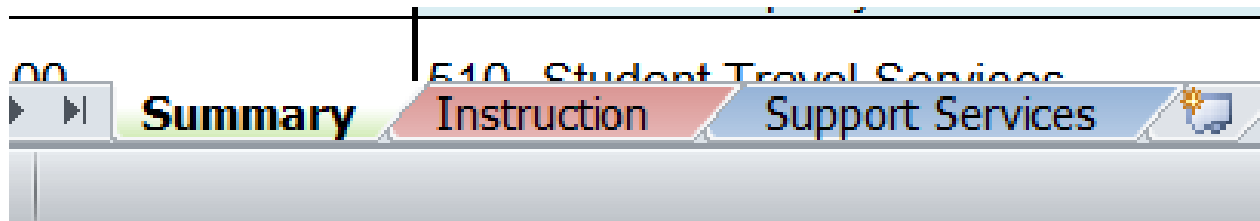


# Narrative

- Times New Roman, 12 font
- Each question limited to 3-pages each
  - Reference pages in Needs Assessment or /Improvement Strategic Plan if needed
- What is the school's need?
- What is the implementation plan for the activities being requested? How does this support your entity's performance/improvement/strategic plan?
- What is the evidence supporting the effectiveness of the proposed strategies, activities, or interventions?
- How will the effectiveness be monitored and measured?
- How did your entity engage stakeholders, including parents, in identifying needs, developing the strategies, and assessing the effectiveness of the activities?

# Application Budget

- 3 Tabs (all must be filled in)
- Narrative is scored
  - Very detailed description
  - Costs are accurate and totals match the Summary page
